



Trading Campus Website Policies

Following sections outline the various terms of the Privacy Policy implemented and followed by the 'www.tradingcampus.ae' (Trading Campus).

Please read this Privacy Policy carefully and be aware that you agree to be bound by this Privacy Policy by visiting the Trading Campus website/s and/or sharing information with Trading Campus. The Privacy Policy may be revised and/or updated at any time without any advance notice.

Envision Training Centre the owner of Trading Campus gives utmost importance to the protection of the privacy of all the information provided by our website users, email subscribers, and subscribers of our digital format or any other clients/users (Users). The aim of this Privacy Policy (Policy) is to govern the manner in which Trading Campus interacts with its Users and to govern our relationship. This Policy is applicable to all our products and services.

Trading Campus encourages Users to review the privacy policy and get back with any suggestion/feedback.

1. User Information and Data Collection – Process

Trading Campus collects information (personal and non-personal) and data from website Users in various forms and means. Information and data collection happens from our websites' visitors, clients, members and subscribers. Information collected from Users is also through filling a form or sending emails. Generic and appropriate information is collected such as name, contacts details, work details, email ids. The information such collected is used to provide better user experience, customised services and issues resolution. Such information is also used in marketing and auditing purposes for computations regarding readership, page views and circulation figures, amongst others.

We also collect appropriate non-personal information regarding the mode and means of communication with our websites, the time spent, pages visited, information about the computers used, amongst others. Our web servers automatically collect limited information about your computer's connection to the Internet, including your IP address, when you visit our websites. Your IP address does not identify you personally. We use this information to deliver our web pages to you upon request, to tailor our websites to the interests of our users, to measure traffic within our websites and let advertisers know the geographic locations from where our visitors come.

It is always your option not to provide the information we request. If you choose not to provide the information we request, you can still visit and have access to most of the information from the websites, but you may be unable to access certain options and services.

When you register or become a member, client or subscriber of Trading Campus or provide information to us in any other manner, you agree to provide only true, accurate, current and complete information.



2. Communication

The Information and Data collected by Semantics and Bridesshop may be used as following:



- a) To send any news/information, emails and newsletter
- b) To manage and run any campaigns, promotions, contests, surveys, etc
- c) To send Users information they agreed to receive

If at any time the User would like to unsubscribe from receiving future emails or communications, they may do so by contacting us via our website or email us to unsubscribe.
